

CIRCULAR FOR PARENTS
OF CLASSES LKG TO I (2022-23)

Dear Parents

1. The revised Age Criteria as per NEP-2020 for Admisssion in Air Force Schools is as under:-

Class	Revised Age Criteria
LKG	04 years as on 01 Apr 2023
UKG	05 years as on 01 Apr 2023
Class I	06 years as on 01 Apr 2023
Class II	07 years as on 01 Apr 2023

2. As per the recent advisory received from Directorate of Education on revised Age criteria the following is to be noted:-

(a). The revised age criteria is to be implemented only in LKG in academic year 2023-24 to maintain parity with KVs.

(b). The parents of underaged students in classes LKG to class I during the year 2022-23, will be given options to either repeat their wards in the same class or get them promoted to the next higher class by submitting an undertaking in the form of a Notarised Affidavit. Parents who opt for the promotion of their underaged wards are to get the Notarised Affidavit on ₹10/- Non-Judicial Stamp Paper. The format of the Notarised Affidavit is annexed herewith for your ready reference.

(c). However, all students of LKG, UKG and Class – I of 2022-23 so promoted to next higher class would throughout remain underaged for admission to KV on transfer and/or may encounter any associated eventuality as and when some provisions are introduced.

3. All such parents (GV and AV camp) who wish to get their wards promoted to the next higher class are to attend the **Orientation at 1000 hrs on 01 April 2023 at GV camp** and **submit the Notarised Affidavit** in person to their respective class teachers on that particular day. **Please strictly adhere to the timings.**
